Geoff has spoken to Tony. The conversation went well. Key points Geoff made to Tony are outlined below.

- 1. If you believe science is being 'ignored' or 'downgraded' in State Govt decision-making process?
 - I have seen no evidence that science or scientists' views are being ignored by either side of politics in Queensland
 - I've been encouraged by the support shown to science by both sides of government and the bipartisan approach to science in Queensland
 - I look forward to meeting with Campbell Newman in the near future
 - The progress we've made in Queensland over the last decade about the importance of science is remarkable
 - There seems to be evidence of a real passion for politics from both sides of Queensland government
 - I'm a huge fan of what's been achieved under the Smart State initiatives

Follow-up question re: Campbell Newman's comments

- I will have to meet with Campbell Newman
- I think it's great he believes in science
- 2. What is your role now and do you see it any different in the scenario that Campbell Newman is describing in the stories above?

On Geoff's role:

- I'm involved strategically as a figure head
- I work mostly with senior bureaucrats
- One of my focuses is on maintaining and building on the momentum that's been achieved e.g. partnership with Chinese Academy of Science
- I am an evangelist and advocate for science and passionate about making sure science gets converted into action

Follow-up question on the type of advice Geoff gives:

- Report for the floods commission
- Hendra Virus Taskforce
- Smart Futures Funding
- Next phase of the Smart State Strategy

3. What is your view on putting a price on carbon emissions?

- I think it's a worthwhile initiative long-term
- I think science informs the political debate
- I'm not a climate change expert or economist
- I'm strongly supportive of research
- I believe there is strong evidence of global warming and we need to reduce carbon emissions
- The Federal Chief Scientist and I are in agreement about this
- I believe we do need to put a price on carbon to change behaviour
- The details of what price and how to implement this are for politicians to work out
