

I have noted your support for the Queensland Government to exercise its call in powers regarding the Jewel Resort Hotel development given that two separate Notices of Appeal have been lodged with the Planning and Environment Court.

The minister responsible for planning may call in a development application if he considers the development application involves a state interest. Intervention by the State Government in a development application prior to, or following, a decision by the local government is only appropriate where an interest of economic or environmental significance to the State could be significantly affected by a development approval. Given these are reserve powers, decisions on their use are not taken lightly.

Picture people melding together, playing music, cooking, laughing and sharing their cultures.



QUEENSLAND - NEW SOUTH WALES CROSS-BORDER ISSUES

I write on behalf of Gold Coast City Council in relation to cross-border issues.

Last October, several of my colleagues met with Michael Tennant and Wade Lewis of the Queensland Department of the Premier and Cabinet to discuss local cross-border concerns. The meeting came about in response to the Cross-Border Memorandum of Understanding (MOU), which was signed in August 2011 by your predecessor, Anna Bligh, and current New South Wales Premier, the Honourable Barry O'Farreli MP.

Following on from this, my predecessor Ron Clarke wrote to former Premier Bligh in December 2011, acknowledging the importance of the MOU and Council's desire to work closely with the State on the cross-border issues affecting communities in the Coolangatta – Tweed Heads region.

Our Council has also been liaising closely with neighbouring Tweed Shire Council over the past year to jointly identify local cross-border issues and it is in relation to this work that I mainly write to you about.

Premier, the communities of Coolangatta Tweed Heads and surrounding areas have been putting up for years with problems stemming from a lack of integrated planning and service delivery by state (and to some extent local) governments. Whilst the following list is by no means exhaustive, it does provide an indication of some of the important areas where cross-border differences are creating problems for us and our southern communities:

- Public transport (including taxis)
- Servicing major developments (for example, at Cobaki) and managing growth generally
- Child protection and guardianship (legislation and practices)
- Access to health and social services
- Community safety
- Sport and recreational facilities (planning and provision)
- Disaster/ emergency management
- Pest animal and plant management
- Companion animal management
- Environmental and water cycle management

What I believe is required mostly now is leadership to bring together all of the parties so that they may resolve all of the issues at hand, once and for all. I include the Federal Government in this equation, for without their whole-hearted support, inter-governmental reform will simply not achieve its full potential.

The commitment by the Queensland Government to establish a Cross-Border MOU with New South Wales last year and begin consulting with border communities and councils was very much appreciated by us. Your confirmation that the Queensland Government under your new leadership will continue to work with us and other stakeholders to resolve the cross-border problems besetting communities in the Coolangatta - Tweed Heads region, would be equally well appreciated.

I intend writing also to Premier O'Farrell, seeking a similar assurance. It suffices to say, both you and your staff are most welcome to visit the Gold Coast at any stage to hear first hand about the cross-border issues we face.

Without wishing to pre-empt any inquiries or findings that the Auditor-General may choose to make, I would appreciate your comments on Contrary to Publishing and your advice on what actions council is taking to ensure the cost effectiveness of this project.

I appreciate that decisions relating to this project were made by the previous council administration, however, Contrary to Public Interest appears to be concerned that this is an ongoing issue.
