

Background arts information that may be useful today

In 2011/12, the arts portfolio was allocated a total of \$267 million for recurrent expenses. (For grants through Arts Qld, State Library, Qld Art Gallery, Queensland Museum etc)

In the 2012 calendar year, literary initiatives worth more than \$800,000 are being supported through Arts Queensland, including the Brisbane Writers Festival, the Queensland Poetry Festival and the Queensland Writers Centre.

JOURNALIST:

The waterfront, the ports, looks like in some of the other States there has been issues, systemic issues with the Ports and the Federal Government's launched a task force and an inquiry. Do you share their concerns about Brisbane?

PREMIER:

Look, I don't have any information about the Port of Brisbane, but elearly there are problems interstate and Brisbane, indeed the Queensland Government will play its role in sorting out these issues because clearly they are a national issue to be dealt with because its ultimately going to be about organised crimes sadly, and criminal gangs. Hi Brad,

I hope you are well and settling into Brisbane life. Surely the weather is much nicer up here!

Now we have had a little time to breathe post Election's please find attached the QLD 2012 Expenditure Report, updated to include the February, March and April figures. We are also working through a post campaign overview of the QLD State Election for you.

February 2012

Total recorded advertising spend for QLD in February 2012 was \$1.7 million. This was a 45% increase on February last year.

The QLD Dept of Health spent the most in February with a \$515k spend, up 183% on the same month last year but down 24% on the previous month. Even as the highest spender this month the departments remained as second highest spender YTD.

The QLD Dept of Transport & Main Roads (\$400k) ranked as the second highest spender in February and was up 76% on February 2011 but down 57% from January (\$940k). It remained the highest spender YTD.

The QLD Dept of Infrastructure & Planning was the third highest spender with an expenditure of \$291,000. This was down 10% YOY and on par with the previous month.

A monthly spend of \$70k saw the *QLD Electoral Commission* jump into the top ten spenders YTD, knocking out the *QLD Dept of Employment Economic Dev and Innovation.*

71% of all expenditure in February 2012 was recorded against the Top 3 advertisers (with a total of 17 recorded line departments).

<u>March 2012</u>

Total recorded advertising spend for QLD in March 2012 was \$1.8 million. This was a 7% decrease on March last year.

The *QLD Dept of Health* spent the most in March with a \$501k spend, on par with the February spend. This is a 38% decrease YOY, but pushes the department to #1 highest spender YTD nonetheless.

The *QLD Electoral Commission* ranked as the second highest spender in March and jumped from #9 to #4 YTD with a monthly spend of \$445,000. This was up from no spend in March 2011, and an increase of 536% from February.

The QLD Dept of Transport & Main Roads was the third highest spender with an expenditure of \$303,000. This was down 24% on February and up 66% YØY,

69% of all expenditure in March 2012 was recorded against the Top 3 advertisers (with a total of 16 recorded line departments).

April 2012

Total recorded advertising spend for QLD in April 2012 was \$993k. This was a 60% decrease on April last year, and down 45% on March.

The QLD Dept of Transport & Main Roads spent the most in April with a \$376k spend, 24% up on March spend. This is a 27% decrease YOY, but the department remains #2 YTD.

The QLD Dept of Health ranked as the second highest spender in April and remained #1 YTD with a monthly spend of \$358,000. This was down 29% from March, and 59% YOY.

The QLD Electoral Commission was the third highest spender with an expenditure of \$109,000. This was down 76% on March but up from only \$2k spent in April 2011.

85% of all expenditure in April 2012 was recorded against the Top 3 advertisers (with a total of 17 recorded line departments).

- Start updating Toowoomba Second Range Crossing Business Case

- Identify the first 150 classes to be funded for more hours for Prep teacher aides

CHRIS ADAMS:					
In the studio joining me is Pren	nier Campbell Newman.				

PREMIER:

G'day Chris, been a while.

CHRIS ADAMS:

It has been a while since we caught up. Good to see you though. I know you will take some calls from listeners as we proceed this morning. We have got about half an hour with the Premier. 13 13 32 is the number if you would like to do that.

Before we get to State based matters perhaps, can I ask you about suggestions today that Clive Palmer has been involved in some sort of get together with Bruce McIver, the State President here, to try and take control of the Liberal Party nationally.

PREMIER:

I don't really comment on internal party matters because my job is to look after Queensland and that is my focus. All I will say on it is that Bruce McIver has been a great President of the LNP. I wouldn't be sitting here, Queensland wouldn't have got a new Government that's working so hard at the moment to sort out the problems and get the State back on track if it wasn't for his leadership. So, he's done a great job as the President of the LNP.

CHRIS ADAMS:

Have you had any approaches from Tony Abbott regarding this matter?

PREMIER:

I talk to Tony Abbott all the time. In fact, I talked to Tony Abbott just before I came in here about another matter. So, look, it has come up, but it's more the fact that I believe that Bruce has been a great President of the LNP. What he chooses to do in the future is a matter for not me; it's a matter for the members of the Party and indeed the Executive of the Liberal Party.

CHRIS ADAMS:

Is Clive Palmer becoming a bit of an embarrassment?

PREMIER:

Well, he's larger than life. That's for sure. Again, as I said all the way through the campaign, he's not on speed dial. For listeners, Newman offers mobile phone to Chris to have a look at. I don't even have his number. There you go. You see, Clive Palmer doesn't have any undue influence over this Government, I promise Queenslanders that. He's another person in the business community who we hope will invest in Queensland and if he's got good projects and good proposals, he'll get the Government's backing.

CHRIS ADAMS:

There is a situation involving Clive Palmer at the moment. Yabulu, just north of Townsville, where one of his nickel plants, or the nickel plant there, has a lot of contaminated water that looks like, if we got another heavy wet season could do damage to the waters and the Reef in that part of the world. Are you across that situation?

PREMIER:

Look, I am and the bottom line or the short answer on this is that he has got to fix it up. Any argument that jobs are going to come before the protection of the Great Barrier Reef doesn't wash in 2012. Similarly an employer who suggested "I don't have money to do up my plant, my factory," even though workers are

being injured or even killed, that doesn't wash in 2012. Mr Palmer and his plant and his managers, they have to deal with the issue. They cannot release contaminated water into the Great Barrier Reef Marine Park. And this Government will enforce the laws without fear or favour.

CHRIS ADAMS:

Okay, I suppose the question that is allied to that one is how did it get like that? Do we know that and are the protections that we have in place good enough?

PREMIER:

The background of this plant is it used to be owned by BHP. Everyone knew there were some significant environmental issues and when Mr Palmer took it over and saved a lot of jobs, which was greatly appreciated in the Townsville community, everyone knew though there was an issue to deal with. So these are not new revelations in terms of there's a problem there with the way that tailings and water that's come out of the plant are dealt with. So, frankly, my position is that Mr Palmer and his firm went in with their eyes open. I just say again for Queenslanders, it doesn't matter whether it's Chive Palmer, Fred Smith, or Sally Jones running a business, the environment will be protected. That's why, for example, we're prosecuting Orica at the moment in Gladstone for letting stuff go into the harbour and I just say that we will enforce the laws here in Queensland the same way we will with the nickel refinery. You cannot make an argument that should be able to release chemicals or contaminated water, into the Great Barrier Reef Marine Park. It's simply not on.

CHRIS ADAMS:

Righto, good. There was a fair bit of focus on your first 100 days when you got into power. It seems to be a measure that we use to judge governments in terms of how they're progressing. You had some pretty specific targets. Just outline the main points of those again for us and let us know where you think you are now progress-wise?

PREMIER:

Well, that would probably use the rest of the program up, but I have got the booklet here. Again listeners, I'm waving it around – it's the First 100 Days. I'm pretty confident that when we get to the date next week that we can say that we've made a good fist of all of the things. So, some of the things that immediately impact on people, for example, the first of July, \$7000 tax off the family home. We've acted to amalgamate the bulk water entities. That was a Cabinet decision actually this week. We've got a selection committee appointed for these scholarships for young women to go to university or for training in various areas that women are under-represented in. We've brought in this week this deal where you can get free travel on *go* card after you've done nine journeys. So, all those things - if people go online and look at the first 100 day commitments, I believe we've delivered. We certainly will have delivered by the cut-off next week. There's a couple of final loose ends we haven't made announcements on. But, it's in the main we've done it. And we can then continue on with the program.

CHRIS ADAMS:

There was one issue that I thought came out of the election campaign and the election itself, which might not have been as formalised perhaps as some of your other 100 day promises or targets, and that was cost of living. Are you; I mean I think it was a real factor in the election...

PREMIER:

Yes I think it is. It continues to be a problem for people.

CHRIS ADAMS:

We're looking to you guys to fix. Do you think you're making significant inroads into doing that?

PREMIER:

Well, we are. If I go back, here are the things that we've done. \$7000 tax off the family home, I mentioned the issue about *go* card, we've frozen Tariff 11 electricity prices for the upcoming financial year – the only increase will be due to the carbon tax, the Prime Minister says we're going to be compensated for that. So, we have done our bit there. We're acting to take the pressure off water bills. I was very happy to hear the Chairman of Queensland Urban Utilities Jude Munro announce the other day that they were going to freeze their price, otherwise people would have been hit with another great whacking increase. So, that seems to be filtering through. Motor vehicle rego for the next three years on the private family car, we've acted to freeze that as well. So, those are real things we've put on the table. And all this stuff that I'm taking about as well with my Ministers about cutting costs, saving money, that's to take the pressure off small businesses, restaurants, people in the tourism industry – they were quite excited yesterday in Cairns about us delivering on that promise as well.

CHRIS ADAMS:

I wouldn't mind talking about the tourism summit again for a moment in a minute. I suppose all of these reductions are fantastic, but I just sense talking to people in the street that there's kind of a; it's not even a concern, it's a suggestion of a question in their mind that with some of these cuts, are we cutting stuff that is really essential and perhaps shouldn't be cut?

PREMIER:

We are committed to actually ramp up frontline services. So the important delivery in hospitals and the police on the street, that's the area that we're focussing on. The savings and cuts we're making are meant to be back of office, back of house. So, I keep saying to my Ministers, and indeed the Directors General, I say this: look to make the savings within 300 metres of where you're sitting. In other words, I'm saying "you need to focus on making those savings in head office". And every now and then, a story comes out about supposedly something that's been cut over there or a service isn't happening there. I'm quite happy for people to tell me if they think that's happening.

CHRIS ADAMS:

How do they do that?

PREMIER:

Well, they can email me. If they go onto the website they will see my email address and postal address. They can contact me that way. I'd like to know.

CHRIS ADAMS:

Because you hear things like; people have said to me like "oh, they're cutting all the midwifery services" and "there are rural fire fighters who aren't going to be available if we have a bad fire season".

PREMIER:

Look that is not what we're about and it's not true, but there's a lot of mischief being spoken at the moment. I'll try this on you. How, in a public service of 208,000 people, that's full-time equivalents, since we got into Government what do you think the headcounts gone down by?

CHRIS ADAMS:

Probably none.

PREMIER:

That's pretty much right.

CHRIS ADAMS:

It's contractors you're cutting, isn't it?

PREMIER:

Well, temporary staff and contractors and consultants. They're the ones sadly who've lost their jobs. You'd think there's been this bloodbath. There has not been. But, we do have 20,000 full-time equivalent positions that we cannot afford as a State. People say they want the cost of living dealt with, they want us to deal with the debt, they don't want high taxes and charges. Well, something has to give. And that's what we're talking about. So we have to actually prune back the back of office functions, the terrible waste and inefficiency that we've seen, and actually then, in a progressive way, try and get the budget balanced.

I'll try this on you. Guess how much the previous Government spent on advertising in one full last financial year? \$100 million, \$100 million. \$2 million a week. So I get a bit amused when I see the Opposition sort of saying "oh gee, he spent supposedly \$40,000 on air on an ad". We're not into blowing our trumpet with public funds. There is actually quite a difference there. We were talking about the gravity of the situation.

CHRIS ADAMS:

Oh, and I think people get that. But, on one hand, as you say, they want everything. On the other hand they want to see cuts as well. Hasn't anyone ever said to you why would you want to become a politician?

PREMIER:

Look, I don't think I've got any credibility if I pull the violin out this morning on that. I think your switchboard will light up. Bad luck mate.

CHRIS ADAMS:

It's already lit up and we must ...

PREMIER:

But look I just stress, if people think that something has been cut that is truly a frontline service – so that means nurses, doctors, fire fighters, police officers, people doing stuff for us, then let me know and I'll certainly get you some answers about that. And it shouldn't be the case because, again, what I'm focussing on is what never happens in bureaucracies. Bureaucracies, the chiefs of these big companies or big bureaucracies, government departments, they never cut the head office. It's always the people in the frontline who cop it in the neck, and then the public and I'm determined that that isn't the way it's going to happen.

CHRIS ADAMS:

Well, the switchboard has lit up. Gina at Graceville

CALLER:

Hi Campbell, You've spoken a bit on cuts. How about cutting voted out politicians' benefits, especially those who sent the State broke?

CHRIS ADAMS:

Any moves in that direction?

PREMIER:

Honest answer, of course not. No one wants to pay politicians anything and I understand the sentiment of the community. I will say that politicians, while we're undertaking these very important reforms and having such a tight rein on the budget in Queensland will have to take the medicine the same as the rest of the Public Service. We're public servants as well. But in terms of former politicians' benefits, I mean, how would any other person in the workforce feel if a new management came in and said we're going to basically 'do you over'. I just don't think it's right or fair

CHRIS ADAMS:

I think a bit of this sentiment's come from the concept that if people run a State and they leave it in a mess then they go away and they end up with a lot of entitlements, people are entitled to ask the question, 'should they be held responsible?'.

PREMIER:

I feel the same way. I'm not here to talk about; we had an election campaign, we're through that. But look, I feel the same way, but at the end of the day, how do you do that? How do you do that fairly?

CHRIS ADAMS:

Tough one. Peter at Deagon, good morning.

PREMIER:

G'day Peter.

CALLER:

I have a question. If Queensland, we have a population increasing each week by about 2000, 2000+.

PREMIER:

Not at the moment Peter, I'm afraid. They're staying away. That's what the stats have shown.

CHRIS ADAMS:

That might be a good thing...

PREMIER:

Well, some people would agree, yeah. But sorry, go on.

CALLER:

How can we actually justify the slashing of 20,000 public service jobs?

PREMIER:

Well, Peter, it's a fair question anyway. It's like this, every year the Government raises money from taxes and charges on Queenslanders and it gets money from the Federal Government. At the moment, if you just look at the underlying figures, Queensland will receive about \$44.5 billion and we will spend about \$47 billion. So we will receive less than we're spending. So, there's a gap. Depending on how you cut the figures, there is a very big gap. It's being propped up this year a bit because we're getting money from the Federal Government for money we're not going to spend until the next financial year, because they wanted to be able to report a surplus, so that's what's going on.

But the point is this; if you're spending more than you bring in, what's going to happen? Something's got to give. You can borrow and that's what the previous Government was doing, and we're still doing that now to keep the State running, but we can't keep doing that. That's why we're talking about, again, massive explosions in debt. The previous Government, they had figures, they said there was going to be \$85 billion worth of debt. We have got a report that says it could go as high as \$100 billion, so what's another lazy \$15 billion? It's an immense amount of money.

The point is; I'm just trying to tell Queenslanders the facts. We have more people, we're doing more than we can afford. So, what are your choices? Do you want taxes and charges to go up?

CHRIS ADAMS:

Well, no. Of course not.

PREMIER:

Well, we don't, because there's cost of living pressure. So the only way to deal with this is to actually curtail the amount we're spending. And I'm really sorry for the people who have been on temporary contracts, and the like, who are not going to be renewed. Behind every single person there is a really bad story and I've already said this, people have come up to me and poked me in the chest and said, 'you've cost me a job'. And I've said 'I'm very sorry' but what am I meant to do? Again, the big issue at the moment is the pressure on people's family budgets and that's what I'm trying to protect, while getting the thing back in the black.

So, fair question, but that's the problem. And, I'll keep talking about it until people really do understand the gravity of the situation. If they go on the internet to <u>www.qld.gov.au</u> there is this report. And people have been going, 'Oh, it's Costello. It's political'. Well, it was also Professor Sandra Harding from James Cook University in Townsville and also Doug McTaggart, who is the Head of the Queensland Investment Corporation. All three individuals have been given jobs and been asked to do various tasks by both Federal and State Labor Governments, so they are respected people and it's a fair dinkum report and I urge Queenslanders to have a look, if they want to know what we're trying to do.

CHRIS ADAMS:

I go back to the point I made before, I think implicit, whether it was a core promise or not, in the last election campaign, was this issue of the cost of living. And people are up to here with it.

PREMIER:

It is. And that's why we're paying more for water. Because there is a massive amount of debt incurred to build all that stuff back in the drought. We're paying more for motor vehicle rego, or we have been, because they were so desperate to prop up the coffers. Similarly they were increasing public transport fares 15 per cent each year for the last three years and we're trying to put a brake on that, we're only going to have a 7.5 per cent increase, which is a very big increase still, I acknowledge, but it's better than 15 per cent.

CHRIS ADAMS:

I know you're pressed for time, and you need to get back into town, but we'll get one more caller in. Geoff, at Greenbank, how're you going?

CALLER:

Good morning Chris, good morning Mr Premier. This doesn't really affect me, but it's a question a lot of pensioners out there that actually live in public housing, that have had families, they've grown up with their families and their families have moved out and they are now in a single house. You can't expect people to take in somebody that probably has come from other public housing, don't care about the public housing. They come and go at different hours of the night and these pensioners have got in a routine over many years, and now you're going to upset the way they live their lives in their older age.

PREMIER:

Well, what Geoff is referring to here, Chris, and for listeners, is again, we've got another big bucket of custard that we have to sort out that we've inherited. And that is that the public housing system is in crisis. There are, I think the figure is at least 30,000 people on the waiting list and there's no money to build new houses. And yet, what we've got is we've got people who are living in public housing and, just as Geoff said, there's an elderly man or woman living in the house where they used to live with their family. And yet, we've got families on the waiting list. So, we've got one person in a three or four bedroom home. So, what we're trying to do, and we're going to do it very sensitively, is we're trying to say: Look, we'd like to go and get you a one bedroom flat and it's going to have to be nearby because we know people have to be near their networks. Their doctor and the pharmacist, and the local shops, and their barber, and all their friends. So, we have to try and do that. But, we're saying to people, look we're just sort of putting people on notice that we're going to have to have more flexibility in the public housing system. So, we want to try and build some new apartments in partnerships with the private sector, using government land that we've got, getting Commonwealth Rent Assistance coming in to help there, and then try and get the families in from the list. So, this isn't about booting people out because they're heartless, it's about caring for people on the list.

So, Dr Bruce Flegg is the housing Minister and he's trying really hard to sort this mess out. I'm really hopeful actually, rather than being negative about this, I'm very hopeful that if people are prepared to understand what we're doing and give us some flexibility, we're actually going to deliver a better outcome because, I heard a figure the other day; I have checked it yet but I literally was told that tens of millions of dollars are being spent by the Department of Communities, which Tracy Davis oversees, to put people up in motels for an emergency. But they're there day after day, week after week. We've got people in motels. We're spending a huge amount of money on these motel bills as a stop gap. Well, I said to Bruce Flegg and to Tracy, there's money there, we've got land, we've got the Council and Councils willing to help. We have got a whole lot of land near the Lutwyche bus station. This is an opportunity.

But, we do need to deal with the fact that some people are just sitting in these almost empty houses. And I know that's tough if someone's lived their life there, I understand that, but what about the people on the list who are never going to get a roof over their head if we don't have a bit of give and take.

So much to talk about, so little time but good to have you in the studio.







LNP 2012 CONVENTION KEYNOTE ADDRESS

Good morning, ladies and gentlemen. It is a pleasure to be here today.

In March, after 14 years of Labor we achieved a result in Queensland that not only changed the Government but gave the LNP a huge mandate to deliver on our plan to get Queensland back on track.

To those of you here today who assisted our team in the campaign I want to say a heartfelt thank you.

You're part of the reason why our Government received a swing of over eight per cent.

You're part of the reason why the LNP now outnumbers Labor 78 to 7.

I want to stress this was a win for Queenslanders. Not me, not the LNP, but an opportunity for this wonderful state to have real change.

We have been given a large majority and we are conscious of that responsibility.

It's our duty to deliver on our promises, deliver honesty and integrity to the very people who put us in this position.

We have hit the ground running, wasting no time delivering on our commitments to the people of Queensland.

We set ourselves an ambitious action plan to complete in the first 100 Days of Government.

The people of Queensland will ultimately be the judge of how we have performed so far, but I am pleased to let you know that we have ticked off on every commitment.

My Ministers, local MPs and I have worked over time to start to deliver real change for Queensland.

Some of the things we achieved in our first 100 days include:

- Commencing steps for a police recruiting surge to meet our commitment to put 1100 extra police on the beat, along with transitioning 200 sworn officers from behind desks back into frontline policing;
- Identifying the first 150 classes to be funded for more hours of prep teacher aides;

We have introduced legislation for tougher sentences for evading police, repeat child sex offenders, murder and serious assault on police officers in Queensland.

And, what I am most proud of is that we've delivered real cost of living savings for Queensland families, including freezing family car rego for the first term, freezing the standard domestic electricity tariff and reintroducing stamp duty concessions for the principal place of residence, saving families up to \$7,000 on the family home and we've acted to put the cost of Federal Labor's carbon tax on electricity bills.

We also commissioned and received an Independent Commission of Audit report into the State's finances, led by Australia's greatest Treasurer Peter Costello, which found Queensland's bottom line is in much worse shape than we thought

The Report shows that thanks to Labor, we're headed for \$100 billion in debt – which equates to interest payments alone of \$115 million a week, or \$685,000 every hour.

To give you an idea of just how big this is, \$100 billion in 100 dollar notes would be stacked 140 kilometres high.

It's billions of dollars that we need to fix our hospitals and our schools, to put more police on our streets and to help lower the cost of living for Queensland families.

The Audit Report recommends some very strong medicine, which we must all take to get our state back on track.

Ladies and gentlemen, as you have heard, we have done a great deal already, despite the economic challenges we face, and I assure you that the energy and commitment my Government has displayed in its first 100 days will not flag.

We are committed to issuing a six monthly progress report on the implementation of the government's 2012 election commitments and other action items.

It is vital that we continue to share our plans with Queenslanders and set out clear delivery targets.

We're doing this because we are committed to delivering on our promises, remaining accountable to Queenslanders and we are not afraid to give them a yardstick to measure us against.

Today I am pleased to officially launch the first Six Month Action Plan of the LNP Government – from July to December 2012.

Our comprehensive Six Month Plan clearly sets out a road map of actions divided up under the five pledges we took to the election in March -to:

- Grow a four pillar economy;
- o Lower the cost of living for families by cutting waste;
- o Deliver better infrastructure and better planning;
- o Revitalise frontline services for families;
- o Restore accountability in government.

There are 149 actions for the LNP Government to complete in our first Six Month Plan, obviously too many to mention here today.

But some of these actions include:

 Queenslanders money and finalise a 30 year plan for the state's electricity sector;

We'll start construction on the long awaited Sunshine Coast University Hospital and prepare draft statutory plans for the Darling Downs and the Golden Triangle. These will be ready for feedback from the community by February 2013.

We'll also deliver a first draft of the 10 year plan for the Bruce Highway, complete the design of the Toowoomba CBD Ringroad and develop a strategy to revitalise the Mary Valley.

My Government will roll out flashing lights in school zones and we'll deliver, in partnership with the sugarcane and beef industries, a framework for a best management program to protect our precious Great Barrier Reef.

In the area of law and order, the LNP Government will appoint new parole board members and issue new guidelines to ensure community safety is considered in parole decisions.

Criminals should be afraid of the LNP. They should clean up their act – or get out. Because we'll be finalising the recruitment of 300 new police, appointing a new Supreme Court Judge and we'll be renewing Neighbourhood Watch and Crime Stoppers.

These steps will help to strengthen community safety and address years of neglect by Labor.

On the issue of accountability, key reforms have already taken place, but we're looking to do more.

We'll establish a Ministerial Code of Conduct that sets a higher standard of performance and behaviour for Ministers, appoint a new Police Commissioner and implement the first tranche of payroll reforms to start fixing Queensland Health's basket case payroll system.

There is a lot to do and for the next six months, this comprehensive action plan will be both a map and a report card.

There are copies of the six month plan available at the back of the room today for you to keep, but it will also be available on the Queensland Government Website for all Queenslanders to access.

I encourage you to tell people about this plan.

I encourage all Queenslanders to print a copy and keep track of our achievements.

And I encourage them to hold us to account because we will also be an open, transparent and accountable administration.

From the first 100 days, to the next six months, to the next election - our intentions are clear.

We will keep our promises to Queenslanders.

We will be open and accountable.

We will keep working towards our goal of reducing unemployment to four per cent within six years by growing the economy with an emphasis upon Queensland's four pillars – agriculture, tourism, resources and construction.

We remain committed to making Queensland the state in which business thrives, and we'll be doing everything we can to encourage business and industry to operate in Queensland over other states.

And we will be a Government that acts on its commitments and gets things done.

My LNP Government has a clear action plan in place to take Queensland forward, and I thank you for your support in making this happen. Thank you very much.

There has been much comment over the details of the budget handed down by the Newman government in Oueensland on Tuesday.

New program to help our children live healthy lifestyle

I am pleased to report that Queensland Health is leading a \$49 million package of initiatives to help children and young teenagers improve their health and stamp out chronic disease.

With more than one in four Queensland children now overweight or obese, the Healthy Children program aims to empower children and young people to make positive and healthy lifestyle choices.

The package of initiatives is aimed at all Queensland children and young teenagers, as well as specific groups that need an extra hand. The Healthy Children program includes 13 initiatives across government and in partnership with many external organisations to improve the nutrition and physical activity of children.

Some examples include:

- The Trim Kids project, aims to support families to adopt healthy lifestyles and promote healthy weight through sustained behavioural change.
- The Good Start program for Maori and Pacific Islander children employs seven part-time multicultural health workers to increase fruit and vegetable consumption and physical activity among kids.
- For our youngest kids, we're giving kindy, childcare and family day care workers the skills to teach children and parents healthy behaviours using fun, play-based activities.
- We're training staff at before and after school care centres about nutrition and physical activity.

The Healthy Children program is a joint Federal and State Government initiative under the National Partnership Agreement on Preventive Health which brings together government agencies and community organisations to help children live a healthy lifestyle.

Warm welcome for royal visit

The Prince of Wales and The Duchess of Cornwall will tour Longreach this month and I have no doubt they will receive a warm welcome from regional Queensland.

Their Royal Highnesses visit to Longreach is an excellent opportunity to showcase Queensland to our visitors.

The program will highlight the challenges of Australia's outback and the positive spirit and personal achievements that have opened up our regional communities.

The Australian visit is based on the central theme of The Queen's Diamond Jubilee celebrations, service to the community, and will take Their Royal Highnesses to both regional communities and major cities around Australia.

The Prince of Wales and the Duchess of Cornwall will also visit Melbourne, Adelaide, Hobart, Sydney and Canberra while in Australia.

Affordability up on LNP fare package

There's no doubt we need to get people back onto public transport and my Government is working hard increase patronage after years of decline.

I'm pleased to say that people are returning. From July to September this year, there was an increase of 640,000 trips. This is a direct result of our election commitments.

We promised free travel after nine journeys in a week, more than 2000 additional weekly bus services, and other improvements to reliability.

On top of that, we announced a record public transport budget of \$1.6 billion back in September, with more than \$200 million in cost-of-living fare savings, which includes halving Labor's planned fare increases.

Of course, affordability isn't the only issue we're tackling. The reliability of public transport, particularly rail, is just not up to scratch, with the recent on-time running performance of QR dropping to 92.51 per cent. The target is 93.01.

The government initiated an independent audit of the CityTrain network following major disruptions in February and March. The audit makes 26 recommendations, all of which will be implemented.

We think there's room to improve the bus network too, which is why we're doing a six month review.

We are also committed to improving the frequency of public transport services .

All these things combined means we're going to see more people using public transport in the future.
