 The Screen Queensland constitution provides that the sole shareholder may appoint a maximum of ten directors. The State of Queensland is the sole shareholder of Screen Queensland.

- Rule 32 (a) of the Constitution provides that the Member may be written resolution (of the sole member) appoint any person as a director.
- Under the constitution and subject to the *Corporations Act 2001* (Cth) Directors' terms may be terminated by written resolution of the members passed in a general meeting or by written resolution of a sole member (Rule 32).

I'm working on tracking down the constitution at the moment to check what it says about the termination of a director's term.


