

WELLCAMP

We built Wellcamp after the Morrison Government refused to build a dedicated quarantine facility, even though it was their responsibility.

The day before Wellcamp was announced in August 2021, we had to pause interstate hotspot arrivals because all our quarantine hotels were full. There were 5,114 people across 22 quarantine hotels at the highest point.

We couldn't have made any other choice.

Because of our health response Queensland has outperformed the rest of the country on employment, domestic economic growth, workforce participation, retail growth and interstate migration during the pandemic.

The only thing we wasted was time – if we had our time again we would have built it earlier.

Background

Costs:

The projected capital and leasing cost will total \$198.5 million.

As at 30 June, the amount paid to Compass Group is approximately \$9 million, publicly reported online. The cost for Aspen medical is a question for Queensland Health.

The Taskforce, which works across all quarantine and isolation including Pinkenba and Wellcamp, cost to 30 June was \$14.3 million.

Between 31 March and 30 June 2022, \$13.549 million was spent on hotel isolation and quarantine. From 5 February to 31 March, \$26.9 million was spent.

Commercial in confidence:

We were able to disclose the overall cost after making the decision to close the facility and advising the Wagners. Estimates was the appropriate place to detail the figures. The detailed breakdown of costs remains commercial-in-confidence.

Other uses:

The design of the facility and its location makes it less suitable to help solve the housing crisis as the other supports required such as access to work, schools and other social supports are not close by.

Wellcamp is a world class quarantine facility, built to keep the COVID-19 virus contained. This means that other uses of the facility are not straightforward.

That said, we are open to any approaches or proposals.

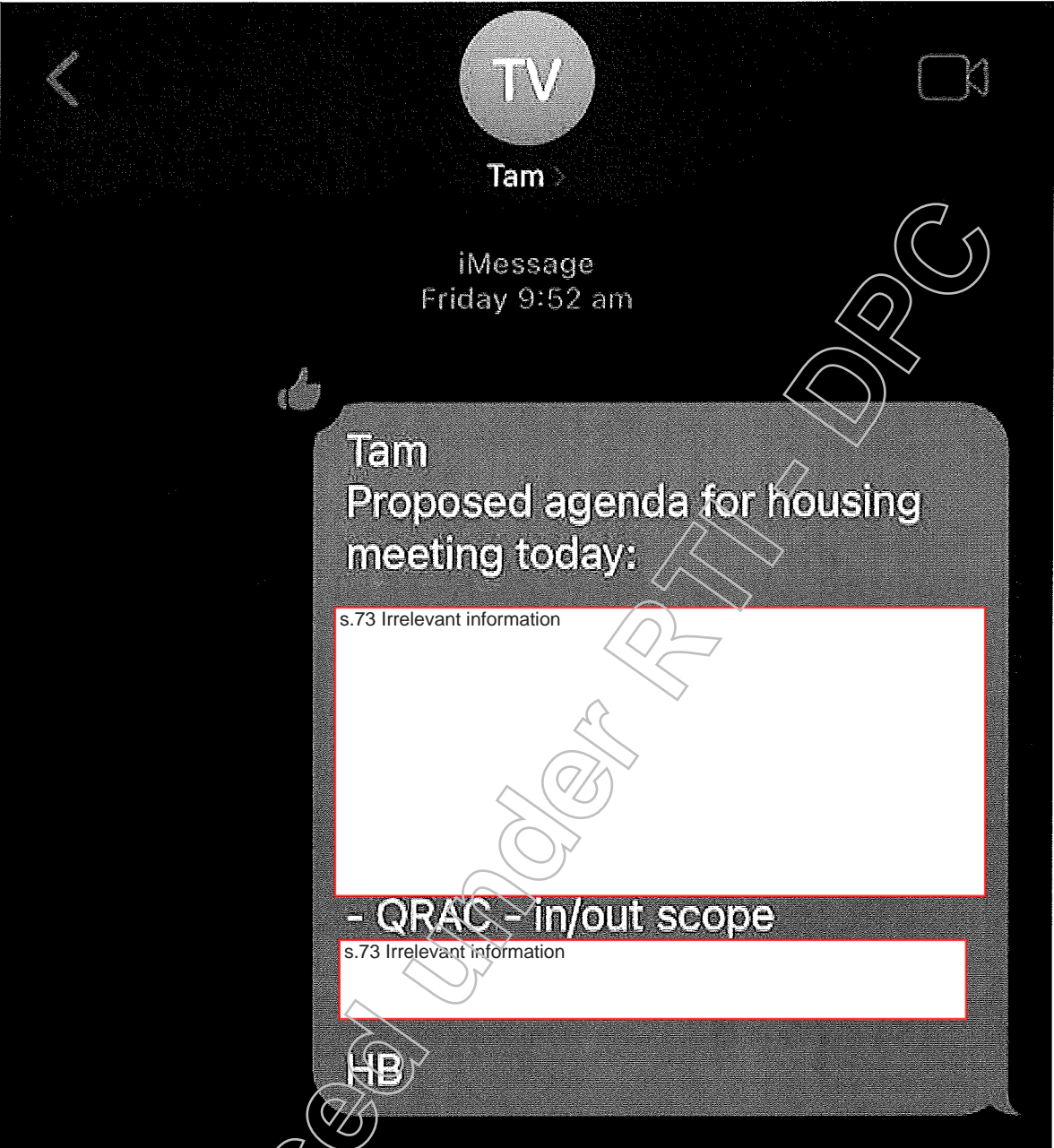

We are now moving to 250 to bring us into line with NSW & Vic given we have no cap on fully vaccinated travellers.

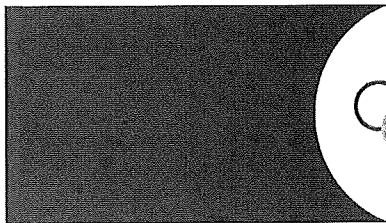
The 250 also matches the decisions to provide space for 250 guests at Wellcamp for travellers.

If you are arriving from overseas into Queensland, you will not be required to quarantine. However you will be required to undertake a COVID-19 test within 24 hours of your arrival. You must self isolate until you receive a negative test result.

If you are not fully vaccinated

If you are arriving from overseas and are not fully vaccinated, you will need to undertake a period of 14 days hotel quarantine and meet existing testing requirements. Additional public health restrictions apply. These measures are outlined in the Public Health and Social Measures.

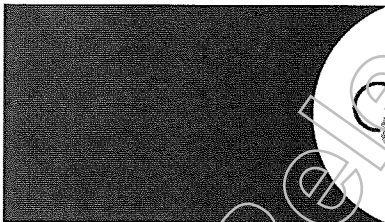

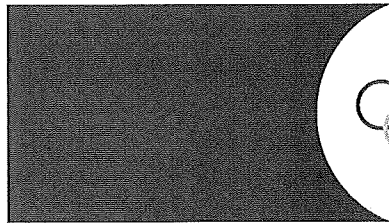

The Premier has written to the PM asking that the current cap on unvaccinated international arrivals (excluding citizens and permanent residents) be reduced from 350 per week (which includes a 100 person contingency) to 250 person per week. This would bring us into line with NSW and Victoria.
No response has been received yet.

Unvaccinated Australians have their 7-10 day quarantine managed either at home, in a quarantine hotel or a the regional quarantine centre at Wellcamp.
Unvaccinated others go to one of the remaining quarantine hotels in their (air) port of entry, with 250 of 500 beds reserved for their use at Wellcamp.

The federal definition of fully vaccinated is two doses, at least two weeks apart, of a TGA approved, or an international recognised COVID vaccine. Booster unlikely to be mandated for international arrivals for some time. The international recognised vaccines includes the main ones from India, China and Russia. You need digital or paper proof in English of your vaccination status: <https://www.health.gov.au/health-alerts/covid-19/international-travel/proof-of-vaccination>
There will certainly be a need for an effective communication strategy with airlines, air port staff, travel agents, and travellers for these ongoing requirements before the volume of tourism arrivals ramps up.

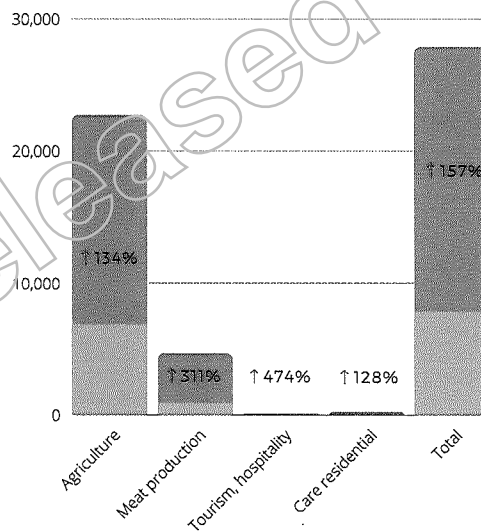

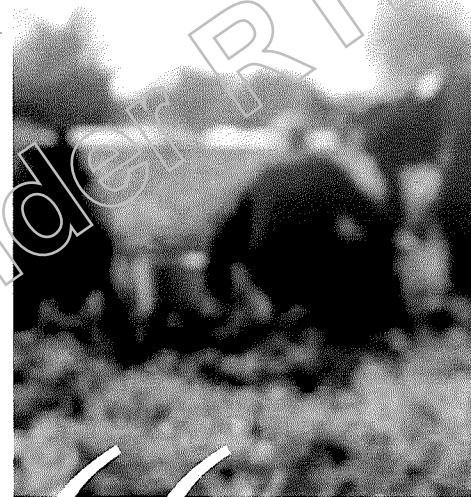
