RECOMMENDATION

It is recommended that you:

- approve the transfer of the Queensland Health Renewal Taskforce (QHRT) from the Public Service Commission (PSC) effective 1 January 2014
- approve the transfer of 10 positions from the Public Service Commission (Attachment A)
- note that Queensland Health (QH) has agreed to contribute \$7.9 million for the continued operations of QHRT
- approve the establishment of expenditure delegations for the following positions:

Chief Executive, QHRT

\$500 000

Executive Director, QHRT

\$100 000

Business Manager, QHRT

\$20 000

KEY ISSUES

- Previously, you have verbally indicated your approval that the Department of the Premier and Cabinet (DPC) become administratively responsible for QHRT. However, to officially effective the transfer of the taskforce from the PSC, your written approval is required.
- It is proposed that the effective date of the transfer is 1 January 2014.
- This transition will see the transfer of the ten FTEs from PSC to DPC. Mr Bill Brett
 prepared Attachment A which lists the staff to transfer and makes a number of actions
 which are complete or underway.
- The Director-General, QH has also agreed to fund \$7.9 million until 31 December 2014 (\$4.3 million in 2013–14 and \$3.6 million in 2014–15). It is planned that this arrangement will be endorsed by CBRC when QH lodge their submission regarding this matter in the near future.
- In order for the business unit to operate efficiently, it is also necessary that you approve appropriate expenditure delegations to key officers within the taskforce.
- The expenditure delegation proposed for the Chief Executive Officer is commensurate with his delegation level currently held within PSC.
