EXECUTIVE SUMMARY - IMPACT

Wave 11 Survey completed 21 – 25 Jan 2022

Impact of COVID-19 on work declining

Self-employed / business owners impacted Overall, Queenslanders who have had their work situation impacted by Covid-19 has remained stable compared to Wave 9. Incidence of Queenslanders who have seen impacts in 'other ways' has increased to 13% (from 6%).

Impact on SMEs and sole traders is on the increase with this latest Omicron wave. They continue to experience a higher level of disruption compared to the average employee (net impact).

Queenslanders feel we act appropriately to COVID-19 threat but those who feel we are over-reacting has increased

The majority continue to feel Queenslanders are responding appropriately to the Covid-19 threat, although significantly lower compared to last wave (71%). Perception of under-reaction (19%) increased significantly from Wave 9 (14%), while over-reaction also increased (up from 15% to 22%).

Queenslanders perceive a much higher risk of getting COVID-19 compared to previous waves. A quarter (24%) say it is definitely likely someone in their family will get COVID-19.

The emergence of the Omicron strain in the Queensland community with the opening of domestic borders in December 2021 has seen a significant increase in perception of 'under-reaction' and an increase in risk of catching COVID, suggesting rising levels of concern in the community. The perception of impact on work is also trending back up, indicating that this new outbreak and the associated restrictions are impacting Queenslander's lives.

There is an increase in perception of both over- and under-reaction with the Omicron outbreak in Queensland (only under-reacting statistically significant at 95%), indicating an emerging polarisation within the community. However, the majority is supportive of the response of Queenslanders. Now that Queenslanders are seeing a significant increase in COVID-19, there is an expected uptick in impact on work.



EXECUTIVE SUMMARY – EXPECTATIONS & CONFIDENCE

Expectations for the economy are more pessimistic

Compared to Wave 9, a significantly greater proportion of Queenslanders are feeling pessimistic, with 42% stating 'the worst is yet to come' and only 11% stating 'the worst is behind us' (versus 31% and 18%, respectively in wave 9).

Two in five (39%) Queenslanders are confident in the Queensland Government's management of the economic recovery.



37% of Queenslanders believe that the Government has been handling the COVID-19 crisis to the State's economic advantage in the long run; the lowest level observed (49% in wave 9).

Optimism about economic recovery within five years declining

Queenslanders' expectations regarding economic recovery remains long term (5 years), with only 44% believing that the economy will fully recover within this time. However, the perception that Queensland will recover within the coming five year period has steadily declined from 67% in Jun'20 (wave 3) to 44% (wave 9). Belief that recovery will occur in the next 12 months has halved (8% from 15% in wave 9).



Pessimism has increased and confidence in the Queensland Government has decreased during this period possibly due to the opening of borders, the Omicron wave, and the testing supply issues.

EXECUTIVE SUMMARY - ECONOMIC STRATEGIES & SUPPORT

Wave 11 Survey completed 21 – 25 Jan 2022

Awareness of economic strategy is at an all time low, with downwards trends in understanding and support.

Awareness of the economic recovery strategy has declined from Wave 9 (20%).

Overall understanding of the strategy is also trending downwards with a third of the Queenslanders who are aware of the strategy purporting they understand it (compared to 50% in wave 9).

More Queenslanders are confident (44%) than not confident (31%) that a strong health response is good for Queenslanders economic recovery in 2022.

Awareness of the State Government's major economic initiatives is at the lowest level (22% wave 9).

Perceived 'Low support' provided by the Government among small business owners/self employed, for small business and for the community has significantly increased since wave 9.

There is an ongoing increasing concern about support being provided to Queensland small business, further impacted this wave with the economic impact of the Omicron outbreak and the business and staffing troubles associated with this.

EXECUTIVE SUMMARY – VACCINES & RESTRICTIONS

Wave 11 Survey completed 21 – 25 Jan 2022

Uptake of the COVID-19 vaccine is very high (87% at least one dose) with three quarters (84%) of those double vaccinated likely to get boosters. However among Queenslanders who are unvaccinated, eight in nine are still unsure or unlikely to vaccinate

The proportion of Queenslanders who rate the Queensland Government as managing the roll out of the COVID-19 vaccine 'well' has increased (40% wave 9).

Are confident that they will be protected from COVID-19 by receiving a vaccine One in two Queenslanders are confident of the efficacy of the COVID-19 vaccine, steady compared to wave 9. However, significantly more Queenslanders are 'not confident' in the efficacy (25% compared to 18% wave 9).

EXECUTIVE SUMMARY - TESTING & BORDERS

Wave 11 Survey completed 21 – 25 Jan 2022

While Queenslanders are concerned about increasing COVID-19 cases due to opening the borders, agreement it was the right decision to open domestic borders is much higher than disagreement (51% vs 34%)

Half (51%) of Queenslanders agree that it was the right decision to open Queensland domestic borders, 34% disagreeing.

Fewer Queenslanders (40%) agree that it was the right decision to open Queensland's International borders, with similar numbers disagreeing (38%).

Three in five (60%) Queenslanders are concerned about the increasing COVID-19 cases with the Queensland borders open.

Slightly more Queenslanders disagree (40%) than agree (37%) that Queensland is well prepared to deal with rising cases with the borders open.

Greater confidence in understanding RAT results than using one at home, while two thirds feel informed about living with COVID and know what to do if positive.

Only half (49%) of Queensland agree that they know how to access the different COVID-19 tests available to them, with 28% disagreeing.

Perception of the level of information from the Queensland Government regarding the current level of restrictions has declined.

The presence of the Omicron strain in the Queensland community is likely contributing to the general decline in perception of information received, with many more factors coming into play (including RAT vs PCR testing, borders opening, and changes in definitions of contacts)

Significantly lower results regarding viewing the Queensland Government as a trustworthy source of information and rating the Queensland Government's handling of the pandemic as 'better' than other states/territories compared to Wave 9 (60% for both in wave 9).

The move towards providing national definitions of cases and contacts, as well as the opening of Queensland borders has likely contributed to the decline in agreement that the Queensland Government has managed the pandemic better than other states/territories.





OBJECTIVES







Findings will be used to inform communications.

This research is to understand Queenslanders' sentiment and views on issues arising from the COVID-19 pandemic. The research will be used to shape the government's approach and communication. The research covers:

- The impact of the COVID-19 pandemic on Queenslanders lives, their jobs and the economy
- The community's views around the economic impact and economic recovery
- The community's views about vaccines and restrictions
- Awareness and effectiveness of communication on current restrictions, Government initiatives, strategies and actions
- Recognition and perception of the 'Economic Recovery' advertising campaign.

This report covers the 11th wave of research which was conducted between 21st – 25th January 2022. The sample was sourced from commercial research panels. Previous waves of research are included for comparison:

- Wave 1: 12 May to 14 May 2020; average 21 minutes; n=1603
- Wave 2: 3 June to 4 June 2020; average 20 minutes; n=1018
- Wave 3: 23 June to 25 June 2020; average 15 minutes; n=1019
- Wave 4: 7 July to 8 July 2020; average 15 minutes; n=1017
- Wave 5: 28 July to 30 July 2020; average 17 minutes; n=1091
- Wave 6: 10 August to 11 August 2020; average 17 minutes; n=1001
- Wave 7: 29 January to 12 February 2021, average 17 minutes; n=1019
- Wave 8: 19 May to 26 May 2021, average 18 minutes; n=1006
- Wave 9: 30 June to 4 Jul 2021, average 16 minutes; n=1042
- Wave 11: 21 January to 25 January 2022, average 22 minutes; n=991 (note: wave 10 was a qualitative data wave and is not reported here)

The composition of survey respondents is displayed in the table on the next page. The responses in this report have been weighted to reflect the Queensland's population using 2016 ABS Census data.

BACKGROUND

Wave 1: On Friday 8 May 2020 the Premier Annastacia Palaszczuk released Queensland's Roadmap to Easing COVID-19 restrictions (the Roadmap). The Roadmap outlines a staged approach to giving Queenslanders more freedom to travel, participate in more activities and hold more gatherings. The Roadmap provides sensible and gradual steps to a COVID recovery that will reconnect our communities and keeps our economy moving by supporting business, industry and Queensland jobs.

- Wave 2: On Sunday 31 May 2020 the Premier announced an update to ease restrictions to Stage 2 at 12 noon on 1 June 2020, which was 11 days ahead of schedule.
- Wave 3: On 23rd June the Queensland Government announced the *Unite and Recover for Queensland Jobs* Economic Recovery Strategy.
- **Wave 4:** On Tuesday, June 30 2020 the Queensland Government announced a further and faster easing of restrictions across Queensland from 12 noon, Friday July 3, including a clear plan to manage our borders going forward. The state's borders would be opened to visitors from other states excluding Victoria from July 10.
- **Wave 5:** On July 27 The Premier urges people crossing the border to be patient with long queues. In this week new cases logged in Queensland and testing increases. On July 30th Queensland Health Officer declares the whole of Greater Sydney a hot spot and restricted access to Queensland from 1 August 2020.
- Wave 6: On 5 August The Premier announces the border closed between NSW, ACT and VIC as more new cases identified with Queenslanders who have travelled south of the border.
- Wave 7: Queensland border closed to Greater Sydney residents during 20 December 2020 to 1 Feb 2021 due to Northern Beaches/Berala outbreaks over Christmas. On 8 January, the Premier announced a three day lockdown in Greater Brisbane which allowed contact tracers to work to ensure the UK variant of COVID-19 was not circulating in the community.
- **Wave 8:** The rollout of COVID-19 vaccines in Queensland commenced 22 February 2021. Borders are open to all other Australian states and New Zealand. However, from 26 May 2021, anyone who has been to any of the exposure venues in Victoria will be required to enter government arranged quarantine.
- Wave 9: 3-day lockdown (29 June to 2 July) in the Local Government Areas of Townsville, Palm Island, Brisbane, Ipswich, Logan City, Moreton Bay, Redlands, Sunshine Coast, Noosa, Somerset, Lockyer Valley, Scenic Rim and Gold Coast, which was extended a further day in Brisbane and Moreton Bay. Mask wearing and gathering restrictions continue to apply across all the aforementioned Local Government Areas. Parts of NSW, WA and NT states were also in lockdown during this period due to community transmission, with border restrictions for Local Government Areas considered COVID-19 hotspots within these states.

Wave 11: 91.8% of Queenslanders vaccinated with at least one dose by 21st January 2022 (89.1% double dosed). At 70% fully vaccinated, 15th Nov 2021, the borders opened to other states with restrictions. At 80% full vaccinated, 13 Dec 2021, arrival from hotspots not longer require quarantine, with international borders opened with restrictions. At 90% fully vaccinated, 15th Jan 2022, international arrivals no longer required to quarantine if vaccinated. Rapid increase in COVID-19 cases from the 13th Dec 2021, and first new COVID-19 related deaths as of the 8th Jan 2022.

The limitations for this methodology include:

- Biased towards those with internet and/or computer literacy
- · Timing of the fieldwork in relation to the announcements of restriction easing
- · Limited time in field may bias to those with more availability
- Vulnerable Queenslanders are less likely to be included in the sample frame and therefore participate in this mode of research.



SAMPLE

Survey respondents were from across Queensland with a range of age, gender and diversity of individuals and households.

IMPACT OF COVID-19 ON WORK SITUATION MIXED






PERCEIVED RISK OF CORONAVIRUS AT HIGHEST LEVEL SINCE INCEPTION OF TRACKER


Perceived likelihood of you getting Coronavirus







Queenslanders views on economic recovery






PERCEPTIONS REGARDING THE ECONOMY IS MORE PESSIMISTIC AND RECOVERY GETS EVEN LONGER TERM

Queenslanders' expectations about the economy is more pessimistic compared to wave 9. A significantly greater proportion are feeling 'the worst is yet to come'.



Queenslanders expectations regarding economic recovery remains long term (5 years), with significantly fewer people believing recovery will happen within 12 months (8% vs. 15% wave 9). The perception that Queensland will fully recover within the coming five year period has consecutively declined each wave, from 67% in Jun'20 (wave 3) to 44% (wave 11).









NOT CONFIDENT IN ECONOMIC MANAGEMENT INCREASES

Queenslanders who are 'not confident' in the Queensland Government's management of the economic recovery has significantly increased since wave 8 and is at the highest level observed. While the largest proportion (39%) are still 'confident', the proportion of those 'not confident' (31%) has increased compared to the last wave (20% in wave 9).



Queenslanders who are 'not confident' in the Queensland Government's handling of the COVID-19 crisis to the state's economic advantage in the long run has also significantly increased since wave 9 and is at the highest level observed. In addition, confidence in the Queensland Government is at the lowest level observed.






Heard about any major economic initiatives implemented by the State Government to assist with COVID-19 recovery?






LOWEST AWARENESS AND SUPPORT OF ECONOMIC RECOVERY STRATEGY



Have you seen, read or heard about the State Government's COVID-19 Economic Recovery Strategy?







MOST PEOPLE DON'T KNOW IF QLD GOVERNMENT HAS AN ECONOMIC STRATEGY

Fewer Queenslanders believe the focus of the QLD Government's economic strategy is on creating jobs by supporting 'traditional' industries (19% vs 28% wave 9). More people believe that QLD Government has no economic strategy than last wave (21% vs 14%).





Perceived 'high support' for small businesses and the community from the Queensland Government has significantly decreased compared to wave 9 and at the lowest level observed on both metrics.


Are you getting enough support from the government as a **small business owner or self-employed**?






FUTURE INTENTION TO VACCINATE REMAINS STEADY, **EXCEPT AMONG UNVACCINATED**


87% of Queenslanders have had any COVID-19 vaccine doses, and 43% have had a booster dose. Among those with two doses, three quarters (72%) are likely to get a booster. Among those unvaccinated, only one in ten (11%) intend to get vaccinated.

Vaccinated for COVID-19




Likelihood to get booster dose of COVID-19 vaccine








CONFIDENCE IN COVID-19 VACCINE ROLL-OUT INCREASED, BUT SOME SHIFT CONFIDENCE IN EFFICACY

One in two (50%) Queenslanders think the COVID-19 vaccine roll-out is going well, the highest level yet, and 57% of Queenslanders things are set up in a way that encourages them to get the vaccine. One in two (51%) are confident the vaccine will protect them from COVID-19, however we've seen a shift from neutrality to a lack of confidence in the vaccine efficacy (not confident now 25% vs 18% wave 9).

Confidence in COVID-19 vaccination to protect




Queensland Government's management of the roll out of vaccines across Queensland



REASONS FOR NOT GETTING THE COVID-19 VACCINE ARE SPLIT BETWEEN LACK OF CONCERN AND WORRY ABOUT SIDE EFFECTS

A third (33%) of unvaccinated Queenslanders don't think they need the COVID-19 vaccine, a third (32%) are worried about side effects, and a third (31%) feel they recover quickly when sick.









Parents of young children (<5 years) are the most polarised when it comes to vaccinating their children. Vaccine is not yet approved for use in children under 5 years.

With 21% already vaccinated, one in two (52%) parents of unvaccinated children **(5-11 years)** are likely to vaccinate their child/ren.

With 53% already vaccinated, 42% of parents of unvaccinated children (12-17 years) are likely to vaccinate their child/ren.





Reasons for *not* getting child/ren vaccinated







PARENTS ARE CHOOSING CHILD VACCINATION LOCATIONS BASED ON PROXIMITY AND AVAILABILITY


Where will/did you take child/ren to get vaccination?



CONFIDENCE IN MANAGING RESTRICTIONS DECLINING


SUPPORT REMAINS FOR RESTRICTIONS AND MASK USE

While support for restrictions continues to lessen (33% now agree there are too many restrictions), 49% of Queenslanders care if business enforce mandates, 59% support continued masks and targeted lockdowns, and 50% would support more restrictions due to Omicron.







QUEENSLANDERS SUPPORT RESTRICTIONS FOR UNVACCINATED

Two thirds (66%) of Queenslanders support restrictions for the unvaccinated and showing proof of vaccination, with 55% showing concern over being around unvaccinated people. Eight in ten (79%) Queenslanders support restrictions for unvaccinated remaining in place at least until Qld reaches 90% double vaccination.







LESS SUPPORT FOR QUARANTINE FACILITIES IN REGIONAL QUEENSLAND

Support for establishing quarantine facilities in regional Queensland is down to 57% (from 72% in wave 9), with even support from SEQ residents (58%) compared to ROQ residents (56%).




TESTING AND BORDERS



DESPITE GENERAL SUPPORT FOR OPENING BORDERS, QLDERS CONCERNED WITH INCREASING COVID-19 CASES


More Queenslanders agree than disagree that it was the right decision to open Queensland domestic borders (51% vs 34%), with less support opening international borders (40% vs 38%). Three in five Queenslanders (60%) are concerned about rising COVID-19 cases, and do not think we are well prepared to deal with rising cases (only 37% agree we are prepared).





Worried about spread of Omicron







QLDERS FEEL CONFIDENT UNDERSTANDING RAT RESULTS, BUT LESS CONFIDENT ACCESSING AND USING RATS

Two thirds (67%) of Queenslanders feel confident they would know the steps to take if they tested positive for COVID-19, however fewer people know how to access RATs (49%) or feel comfortable using them (50%).







INFORMATION SOURCE PREFERENCE IS AUDIENCE-DEPENDENT

Most Queenslanders get information about living with COVID-19 from their GP (58%). Accessing information changes across demographics, with young Queenslanders preferring online (40% 18-34 yrs, 30% 35-64 yrs, 10% 65+ yrs), whereas older Queenslanders prefer face-to-face (7% 18-34 yrs, 22% 35-64 yrs, 37% 65+ yrs) and news (11% 18-34 yrs, 30% 35-64 yrs, 35% 65+ yrs). Males are more likely to prefer face-to-face (25% male, 16% female) and email (26% male, 14% female).










SENTIMENT REGARDING QLD GOVERNMENT'S MANAGEMENT OF PANDEMIC COMPARED TO OTHER STATES DECLINES

One in two (50%) Queenslanders perceive the Queensland Government to be a trustworthy source of information, significantly lower compared to last wave (60%). Half (51%) also rate the Queensland Government's management of the pandemic as 'better' compared to other states/territories, also significantly lower compared to last wave (60%). Agreement levels on both metrics are at the lowest level observed.


