Conroy has just announced on SKY that Telstra has been given the ultimatum on structural separation. They have the choice of HOW to do it, not WHETHER to do it. Reforms to the Telecommunications Act 1997 will be introduced today, to be debated in October/November.

From the press release

Telstra will be prevented from acquiring additional spectrum for advanced wireless broadband while it:

- Remains vertically integrated; and
- Owns a hybrid fibre coaxial cable network; and
- Maintains its interest in Foxtel.

Whatever form the structural separation takes, it must be approved by the ACCC.
