- 1.Thank you for the email. This wording seems reasonable to me, in broad terms I am seeking any correspondence with Seven or other government departments about Operation Bounce Back and think the wording you suggest here captures that clearly.
- 2.So, I am happy to proceed on these terms if I can just clarify two small issues that I set out in my original request.
- 3.Firstly, can I be assured that the term ‘Operation Bounce Back’ will also include instances where it is referred to as ‘bounceback’, a ‘Sunrise’ program, or ‘Sunrise tradies program’, ‘initiative’, ‘volunteer’ effort etc. I know that some of the correspondence from Premiers to Public Works for instances uses terminology like this. For example, in my initial request I asked for any correspondence with Seven West Media (and related companies and programs such as Channel 7 and Sunrise), that related to a “partnership of any capacity including, but not limited to: a program or initiative to rebuild Queensland using volunteer labour, the Premier appearing and/or making announcements on the Seven Sunrise program, or Operation Bounce Back (also known to be referred to as Operation Bounceback, Bounceback, a Sunrise tradesman program)”. Can I be assured that the search will proceed on this basis?
- 4.Secondly, in my initial request to both Department of Premier and Cabinet and to the Premier’s Office I set out a couple of specific items of correspondence. As discussed on the phone, the Premier's Office has received an application under the *Right to Information Act 2009* (Qld) ("the RTI Act") relating to "Operation Bounce Back".

Some correspondence which has been identified as potentially within the scope of this application relates to a Mr Burgess Stevenson, who I am informed previously worked for your office. This information is currently being considered for release to the application, and may subsequently be published online via a disclosure log. The relevant documents are attached in two separate PDFs.

Section 37 of the RTI Act (attached) contains provisions for formal consultation with third-parties to provide them with an opportunity to put forward a case as to why information proposed to be released should not be released. Any such case is required to be based upon Schedule 3 (Exempt information) and Schedule 4 (Factors favouring nondisclosure in the public interest) of the RTI Act (also attached). This is not a formal consultation.

This email is to seek your Office's view as to whether or not you wish to be formally consulted under section 37 of the RTI Act, which would then provide you with access to Internal and/or External Review opportunities in relation to any decision which may be made to release this information.
