- The brief was generated following Screen Queensland's (SQ) request for the department's position on the option.

Dear Deb,

Further to previous discussions regarding the external review by the Office of the Information Commissioner (OIC) on the RTI application by Glass Media (RTID287ER).

I had previously mentioned my view that, if the applicant didn't respond to the OiC's latest letter, then this matter would effectively come to an end (as it did with the Seven Network external review RTID271ER).

However, I have this morning spoken with Jim Forbes of the OIC and confirmed that this is not the case.

Regardless of whether or not the applicant responds to the OIC by the due date (14 June 2016), the OIC will continue with a formal decision that the information in issue (incentive \$ amount) is not exempt information or contrary to the public interest information and therefore should be released to the applicant.

Once that decision is given, any of the participants (DPC/Arts, Screen Queensland or Disney) may seek a review of this decision at QCAT.

This email is merely to advise that my previous assessment (potential for the matter to wither and die) was incorrect.

Here is the decision. As you will see the outcome is very good for Screen Queensland as Justice Sheridan held:

- That the actual figure was exempt under the Cabinet exemption as per Schedule 3, s.2(1)(b) of the RTI Act - that finding alone means that the figure will now not be released;
- That the Information Commissioner was in error in considering that the John Fairfax test created a separate public interest test in terms of the confidentiality exemption - as per Schedule 3, s.8 of the RTI Act;
- That the Information Commissioner took into account an irrelevant consideration by giving weight as she did to the views of the Queensland Competition Authority; and
- That the Information Commissioner also failed in framing her decision to give appropriate weight to the practical and commercial effect of the disclosure of the amount paid to Disney - and in doing so, failed to take into account a relevant consideration;

On the other grounds of appeal Justice Sheridan found that the Information Commissioner's process was unreasonable but that the decision itself was not unreasonable itself as per the decision in Li. The appeal ground based on the Information Commissioner misconstruing the public interest test was also not upheld.

So this a pretty decisive win all round. Justice Sheridan has set aside the Information Commissioners decision and has held that the figure was exempt under the Cabinet exemption - so that is the end of the matter. There is therefore no need for the Information Commissioner to now reconsider the matter as regards the confidentiality exemption and the public interest test. The information is clearly exempt based on the Cabinet exemption finding.
