The impact on the correctional system will of course be taken into account but community safety will be at the core of any future reforms.

I'll be in a better position to formulate the best way to protect the community following the transition of Corrections to my portfolio.

- Q. It's my understanding that it is being floated that the AG consider expanding electronic bracelets for more offenders meaning certain types of offenders, such as young recidivist, dangerous offenders and sexual offenders those other than DIPSOs would be monitored, which would mean it would be clear if they breached their curfew, went to a place they shouldn't or associated with another offender in the community. Last time the AG said he would be open to this. Is this now a live option?
- Q. There's new technology these days, that is improving all the time, that is a GPS tracker AND monitors alcohol blood content. Is this something the AG would consider tapping into to try to enforce alcohol restrictions upon those who are on parole and not allowed to drink?

Expanding the GPS monitoring system to other offenders was just one of several concepts that were raised but it is far too early to say if we would even consider going down that road.

- Q. Is there a board, staffed by DGs and the like, that are looking at the implementations of the Keelty Review and Commission of Audit?
- Q. Who is on the board and how often do they meet?

To ensure the accepted recommendations from the Keelty Review are implemented as quickly and seamlessly as possible an implementation team has been formed.

The team consists of skilled change management, administrative and operational professionals who will begin implementing recommendations immediately.

Q. The number of female prisoners in Queensland has significantly increased in the past few years – and has caught some by surprise. They are clearly committing more crimes and are more violent. What's the AG view on this?

Any spike in crime is a concern and we work with Corrections and Police to formulate ways to combat new trends.

Dear Minister

Thank you for the opportunity to comment on the Commissioner of Police's proposed model for the provision of corporate services to the Queensland Police Service and Queensland Fire and Rescue Service.

As you are aware the Police and Community Safety Review (PACSR) team has provided you with a proposed model for the portfolio that is based on the observations that we have made over the past eight months. My considered opinion is that the model proposed by Commissioner of Police will not address many of the issues raised by the PACSR. In particular it does not resolve the issues of failed interoperability, lack of transparency for Government and ill founded strategic investment decisions.

The QPS proposed model has no basis in fact because it has not been produced as a result of defining and understanding the problems. Importantly it is another example of wasting time and money, and this strengthens the argument for an efficiency review.

By providing one CEO accountable for the delivery of corporate services, the model approved by Cabinet provides a much stronger foundation for a managed service, and therefore for future contestability, interoperability and better investment decisions.

The Commissioner's model does not guarantee the necessary collaboration to deliver interoperability as it relies on relationships that have been observed to be dysfunctional to date. I am also concerned by the complexity of reporting and governance arrangements in the Commissioner's model, with each of the six functional heads apparently reporting to two "Strategy and Business Function Experts".

I therefore recommend that you proceed with the model approved by Cabinet.

Dear Minister

I am pleased to provide you with the final report of the Queensland Police and Community Safety Review.

Since the review commenced on 2 January 2013 the review team has conducted more than 265 meetings and interviews across Queensland with staff, volunteers and stakeholders of each of the portfolio agencies.

I have called the report Sustaining the Unsustainable. This title reflects the enormous efforts of staff and volunteers alike that have resulted in positive outcomes for the community, but who have been supported by systems and processes that are in some cases inefficient and in many cases unsustainable.

One of the key findings of the review has been that response services, which must be reactive to demand, should be aligned with those services which can prevent or mitigate this demand. The portfolio approach proposed in this report is designed to drive improved collaboration and reduce duplication and inefficiency.

The report's recommendations entail significant reform to the portfolio. Implementation teams will need to analyse the legislative, policy and structural issues, and negotiate the details of a model that provides the best possible outcomes for Government and the community.

Although the reforms proposed will result in significant change for many stakeholders I have been pleased with the opportunity to positively engage with staff, executives and stakeholder groups including the key unions.

The intention of the recommendations contained in this report is to build a foundation for Public Safety agencies that will support better processes and outcomes for staff and volunteers. I believe this will ultimately provide a more sustainable approach to delivering quality public safety outcomes for all Queenslanders.
