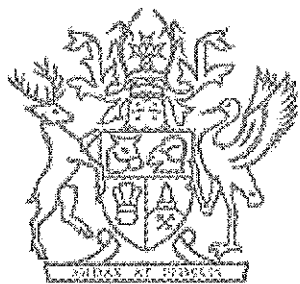

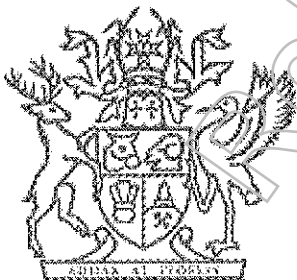

Subject The Attorney-General's trip to Townsville, Rockhampton and the Fraser Coast to announce the expansion of the youth boot camp trial and development of the *Youth Justice Blueprint* on 24 March 2013.

### RECOMMENDATION

That you **note** the expansion of the youth boot camp trial and development of the *Youth Justice Blueprint* to be announced in Townsville on 24 March 2013.

### BACKGROUND SUMMARY

1. An LNP Election Commitment was to introduce a youth boot camp trial to address youth crime.
2. This has been achieved with the initial youth boot camp trial consisting of two youth boot camp programs - A sentenced youth boot camp in Cairns and surrounding areas which became available to the courts on 31 January 2013 and an early intervention youth boot camp on the Gold Coast which commenced its first camp on 25 February 2013.
3. The Attorney-General and Members of Parliament have been lobbied by communities across the State to introduce a boot camp in their region to address youth crime.

### ISSUES

4. On 18 March 2013, Cabinet approved the expansion of the youth boot camp trial to three new locations and the development of a *Youth Justice Blueprint*.
5. The trial will be expanded to enable a sentenced youth boot camp to be established in Townsville and two early intervention youth boot camps to be established in Rockhampton and the Fraser Coast.
6. In the next couple of weeks, the Department of Justice and Attorney-General will commence an open procurement process to select suitable service providers in the three locations. Expressions of Interest for service providers will be called for in the coming weeks. It is anticipated that these boot camps will commence in September 2013.
7. A *Youth Justice Blueprint* will be developed over the next 12 months. The Blueprint will provide a systemic and structural overview of the way reform can be achieved in the medium to long term in the youth justice system.
8. To inform the Blueprint, a Youth Justice Blueprint Information Paper will be released for community consultation to seek input from the public. The Information Paper introduces possible areas of reform and current initiatives including the trial of youth boot camps and the review of the *Youth Justice Act 1992*. Other areas included are other options for legislative reform; strengthening families and the connection between youth justice and

child protection; early intervention and diversion opportunities; responding to causal factors of crime; security of youth detention and improving reintegration of young people into the community; efficient management of demand on the justice system; and non-government investment in the youth justice system.

- 9. The Premier and the Attorney-General will be announcing the expansion of the youth boot camp trial and the development of the Blueprint on 24 March 2013 in Townsville. The Premier and the Attorney-General will then travel to Rockhampton and the Fraser Coast to make announcements.

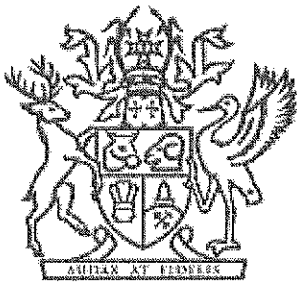

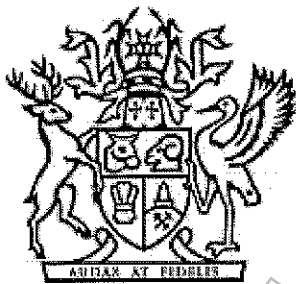

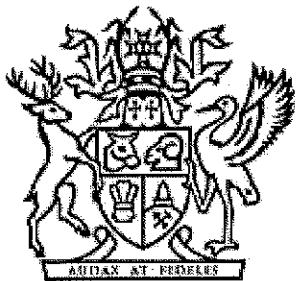
I have some feedback:
