I attach a copy of my letter to the Courier Mail today on the new sentencing provisions. I believe that your government has produced an excellent package of increased penalties, together with some mandatory sentences which will bring about certainty of punishment.

May I urge you to give maximum publicity to the new provisions which will enhance the deterrent effect and reassure potential victims that offenders will receive severe punishment. The publicity should also target young people generally. An offender being released on bail could be given a leaflet to take away, aimed at potential offenders as part of the deterrent.

Since the new measures were announced, there has been inadequate cover in the media and the silly distraction of 'Attempted Murder not being listed.' As I mentioned in my Courier Mail letter, if the prosecution wishes, they can include an additional charge for serious assault/gbh, which can attract a mandatory life sentence.

It would be helpful, from now on, if a few serious cases were fast tracked to reinforce knowledge of the new measures.... Looking from the outside, it does seem to me that cases take a ridiculous time to come to court and I hope that your colleagues are looking into this. Straight forward juvenile, 'guilty plea' cases should be done and dusted in a month and this would relieve the crowding in detention centres due to remand cases.

I am writing to express my deep concern and disappointment regarding the omission of attempted murder from recent reforms to the Youth Justice Act. Attempted murder is undeniably one of the most serious and violent crimes, second only to murder itself, and its exclusion from the legislation raises serious questions about the priorities and effectiveness of Queensland's justice system.

During your election campaign, you made a commitment to address youth crime with the strong rhetoric of "adult crime, adult time." However, leaving attempted murder outside the scope of tougher penalties and accountability measures undermines this pledge. It suggests a significant oversight in addressing the gravity of this crime and the impact it has on victims, their families, and the broader community.

Attempted murder is not a trivial offense—it demonstrates intent to take a life. Such an act should warrant severe consequences, irrespective of the offender's age. Failing to include this in the Youth Justice Act reforms sends a troubling message to the public about the government's stance on serious violent crimes and its commitment to justice.


I urge you and your government to provide a clear explanation as to why attempted murder was not included in these reforms and to

address this oversight as a matter of priority. The people of Queensland deserve a justice system that prioritizes public safety and ensures accountability for the most heinous offenses.

I look forward to your response on this critical issue.

It would be refreshing if those who are decrying the new Governments' penalties for young offenders would read the full description of the measures when they would, hopefully, be better informed and would not express such ill-informed opinions. In my view the new penalties and particularly the mandatory nature of some of the penalties ( i.e. No Judicial discretion) make them very tough indeed and send out a clear signal that committing serious crimes will result in very long terms of imprisonment.

A few examples will illustrate the swingeing penalties which will result.

For Murder the penalty is mandatory life imprisonment with a non- parole period of 20 years.

Robbery with violence – a maximum of life imprisonment with a non- parole period of 15 years.

Burglary by breaking in, using violence, damage, armed etc, Mandatory life imprisonment with a non-parole period of 15 years.

The government should be congratulated in having the political courage to tackle the young criminals who pose such a threat to society. It is now for the judges to play their part!

The new laws should be given maximum publicity, particularly through social media. Taken together they represent a very powerful deterrent to potential young offenders.

Regarding the confected concern about attempted murder not being included, this could be easily addressed by adding an additional count of 'intending to cause grievous bodily harm' for which the maximum penalty is life imprisonment with a minimum non-parole period of 15 years. No doubt the Attempted Murder offence will be included in any event when progress is reviewed.

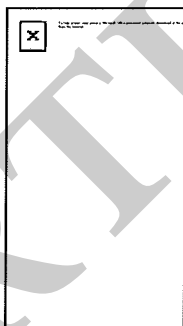

Former Capalaba MP, Don Brown has called upon Russell Field and the LNP to match his plan to fund local youth organisation, Traction. This has followed a recent wave of youth crime across in Redlands, which peaked with 5 cars being stolen and a high speed chase on Australia Day.

"When you have got a Premier who does not include attempted murder as an adult crime, is it any wonder the laws are not working."

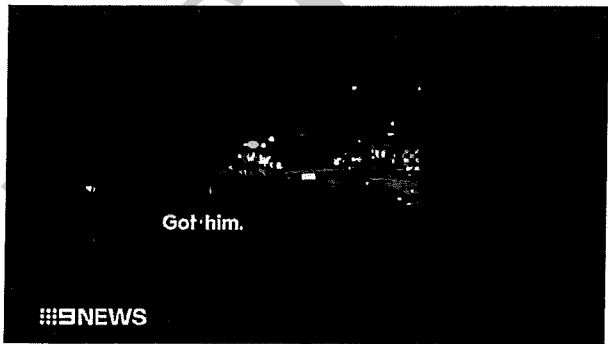
"I am pleased that since the Redlands crime wave started, that Russell Field is now talking up my plan to support Traction in the media."
