





Minister Leahy wrote to you on 1 April 2025, seeking your endorsement of Queensland's 50 per cent contribution towards a jointly DRFA funded, suite of grants to support immediate recovery efforts for councils; primary producers; rural landholders; and small business operators (including not-for-profits):
  - a) \$12 million for Category C Community Relief Fund grants of up to \$1 million to Barcoo Shire; Boulia Shire; Bulloo Shire; Diamantina Shire; Longreach Shire; Murweh Shire; Paroo Shire; Quilpie Shire and Winton Shire and other at-risk councils, as needed
  - b) \$52.5 million for Category C Primary Producer Recovery Grants of up to \$25,000 for impacted primary producers located in Barcoo Shire; Boulia Shire; Bulloo Shire; Diamantina Shire; Longreach Shire; Murweh Shire; Paroo Shire; Quilpie Shire and Winton Shire council regions.

- 4. Should you approve of this approach, it is requested that you write to the Prime Minister seeking his approval to cost share the recovery package (**Attachment 3**).
- 5. Each package has been coordinated by the Queensland Reconstruction Authority (QRA) working with responsible departments to reflect analysis of the damage in the affected areas and results of consultation with the affected communities. The packages are detailed in the formal request forms to be provided to the Prime Minister (Attachments 1a, 1b, and 1c).
- 6. For the Community Relief Fund, it is proposed that grants of up to \$1 million be made available to reimburse eligible costs incurred by councils, noting funding will be allocated

with flexibility to reflect actual needs of councils (i.e. it will not necessarily be equally divided but managed within the capped funding amount).

- 7. The primary producer grants estimate is based on Geographic Information System (GIS) spatial mapping, combined with overlays of predicted flood peaks and synthetic aperture radar (SAR) to determine the potential extent of impacts on specific industries and LGAs.
- 8. The grant programs pay out the actual damage costs incurred as a reimbursement. For every successful applicant, the full grant amount is not expected to be required, creating a buffer in the approved funding envelope that can be used as a contingency, should the actual number of successful applications exceed estimates contained in the request forms.
- 9. The Minister has also sought an increase to the capped grant amount for Primary Producer Recovery Grants, increasing the cap from \$25,000 up to \$75,000, given the size and scale of the event.
